#### **Issues**

We recommend that a Hosted Committee can find members from anywhere in Australia without involving QA Nominations Committee.

o In our *Handbook* (5.3.7.3), it is suggested that members of a Hosted Committee are from within the Host Regional Meeting, although members may also be co-opted. It is not clear from the *Handbook* if these co-opted members are from within the Host Regional Meeting, or from elsewhere within Australia Yearly Meeting. We recommend that Friends may be co-opted to a Hosted Committee from anywhere within Australia Yearly Meeting, without requiring discernment from QA Nominations Committee.

We recommend that if a Working Group wishes to become a Committee, this recommendation should form part of their report to Yearly Meeting for the discernment of Friends.
